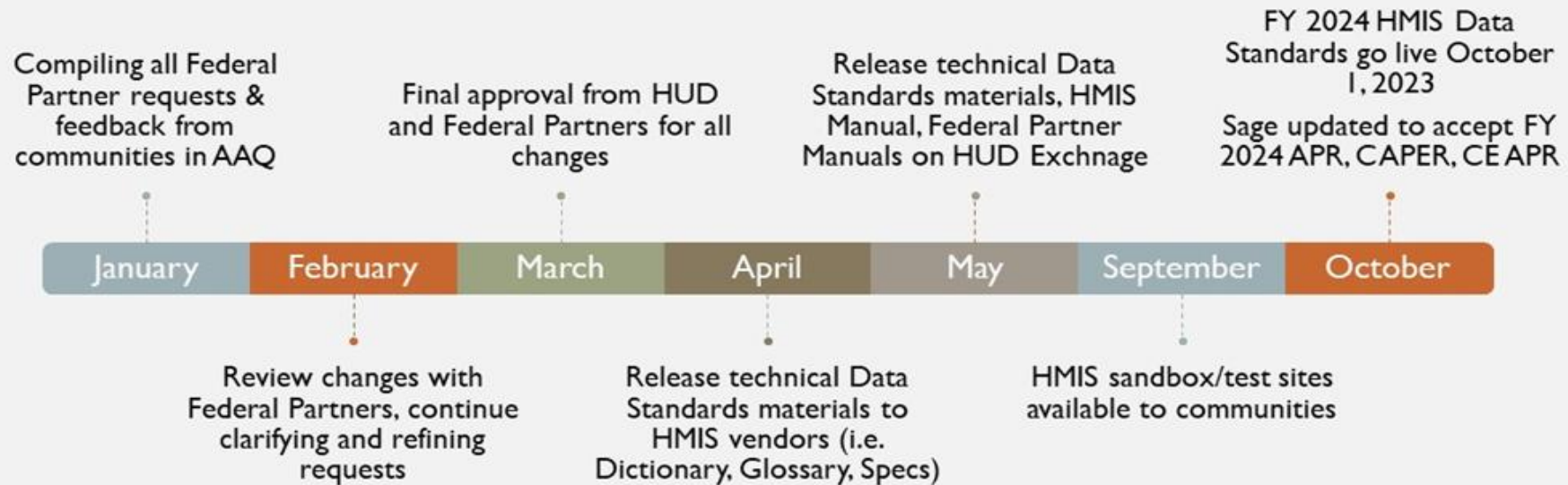

# 2024 Data Standards

## Schedule – Completed items

- Wellsky has released an update with new project and other fields so we can do updates to projects in advance of the main 10/1/2023 release
- September 4, 2023: Wellsky released 2024 HUD Data Standards for a single training site (“sandbox”) and we obtained access to it. We have been using this to scope assessment and reporting changes required
- Changes to CoC Custom Assessments have been identified and catalogued and work plan created
- Changes to reports have been identified and the work plan has been partially completed

# Data Quality Update

DQ Process for 1/1/2023 – 6/30/2023 conducted 8/14/2023 – 8/25/2023

- Office Hours sessions held for several agencies; results were positive
- 259 projects submitted results, which is a significant increase in participation. Thank you!

# ALLINside

The White House, USICH and 19 federal agencies are partnering with **six selected state and local governments** for up to 2 years to strengthen and accelerate efforts to help people move off the streets and into homes.

Chicago, Dallas, Los Angeles, Phoenix Metro, Seattle, State of California

For each community:

- Embed a dedicated federal official (hired 7/2023)
- Deploy dedicated teams
- Launch new efforts to address major barriers
- Convene philanthropy, the private sector, and other communities

Chicago established an MOU with 5 priority areas, including:

- Support to address technical issues that relate to allowing the system to provide added transparency for HMIS partners working across same populations.

This work will be the primary focus of HMIS until completed



# ALLINside

## Next steps:

- Establish a workplan to accomplish this goal of the MOU
  - Review visibility and data sharing to ensure it aligns with client consent and supports access to housing
  - Review assessment structure to facilitate information sharing
- Determine how work will be completed by the HMIS Committee and who else needs to be involved
  - Establish a user group
  - Establish framework for guidance from PLE
- Conduct a legal review to ensure visibility complies with state and federal laws
- Assess privacy policy and consent to ensure they are reflective of changes

Note: This was just announced last week in the HMIS Committee, so work has just begun. We will provide more details as work continues.
